

## General Terms of Use

These Regulations of user interaction on the internet source «[maxmodal.com](https://maxmodal.com)» (<https://maxmodal.com/en/rules/rulesEN.pdf>) (hereinafter referred to as Terms apply to MAXMODAL user interaction within the community of individuals, legal entities or individual entrepreneurs engaged in professional activities related to cargo transportation, providing or using all kinds of serviced in this area or related areas of activity, as well as to any other individuals interested in this matter.

These Terms are an integral part of the Terms and Conditions Agreement, and they use general terms and definitions in accordance with the meaning defined in Terms and Conditions. In the event of a conflict between the General Terms of Use and Terms and Conditions Agreement, the norms of these Terms take precedence.

These Terms apply to all types of interaction between Users within the functionality / services of MAXMODAL.

By using MAXMODAL, User expresses the unconditional consent to these Terms; in case of disagreement with these conditions, the User must refrain from using MAXMODAL.

The following terms and definitions are used in this Agreement:

**Publication** – a post in the MAXMODAL newsfeed.

**Comment** – a message under a Publication.

**Off-topic** – A post or comment in the MAXMODAL newsfeed that does not match the MAXMODAL theme.

**Flood** – meaningless or non-constructive Publication, Comment or Personal message.

**Flaming** – act of posting insults, starting a conflict including profanity or other offensive language or discrimination on any grounds etc.

**Spam** – A post, comment or personal message containing an intrusive offer of the services or services of third parties.

**Necroposting** – publishing posts about old topics where the last comments date more than a month ago.

**Caps Lock** – writing in capital letters ("IN CAPS") the entire message or most of it.

**Moderation** – the activities of the Administration to verify whether the actions of the User are in accordance with the User Agreement and the provisions of the current legislation of the Russian Federation.

Users may be subject to liability measures listed in Terms and Conditions Agreement for violation of these Terms.

Other terms, definitions and phrases used in these Terms of Use have meaning and are subject to interpretation in accordance with the provisions of these Terms, the Terms and Conditions, the established practice of using these terms, definitions and phrases in the field of Internet technologies, as well as in accordance with the current legislation of the Russian Federation.

Within User interaction in MAXMODAL community, it is prohibited:

1. To sign in to MAXMODAL using other user's account regardless of how it was obtained.
2. To use obscene (including veiled, hidden with special characters, for example, @ # \$%), offensive, threatening, discriminatory on any grounds words, profanity (including "Olbanian" jargon) in a pseudonym (nickname), avatar, signature, status, topic titles, messages, in personal correspondence with other MAXMODAL Users on MAXMODAL.
3. Veiled or explicit provocation by MAXMODAL Users to insult and / or starting a conflict among other Users and / or the Administration.
4. To post images, links to images, links to Internet resources containing elements of pornography, violence, propaganda of terrorism, neo-Nazism, discrimination on any basis, alcoholic products or drugs, obscene, offensive messages, profanity, as well as violations of the current legislation of the Russian Federation or international UN standards.

5. Propaganda of any kind of use or distribution of drugs, alcoholic beverages, psychotropic drugs; propaganda of terrorism.

6. Posting or discussion of advertising materials in any way, including sharing links to websites, referral links, spam.

7. Discussion of vulnerabilities or flaws of MAXMODAL, as well as any actions or discussion of actions that in one way or another may violate these Terms. The user, having found a vulnerability or flaw, is obliged to report it to the Administration.

8. Publication of statements notifying about leaving MAXMODAL, as well as messages that could lead to negative consequences for the activities of MAXMODAL.

9. Create posts or comments with flashy headlines or partially written in capital letters (caps).

10. Creation of posts or comments with ambiguous titles (e.g., "Help", "Attention!", "Urgent", "Check it out", etc.).

11. Creation of posts that are identical, similar to the extent of creating confusion, with minimal differences from the original posts or comments. The administration reserves the right to give a final linguistic assessment of the similarity of two posts or comments and not comment on its assessment criteria to the User.

12. Necroposting. It is unnecessary to repeat posts that have not aroused interest of Users.

13. Writing posts or comments that deviate from the MAXMODAL theme (off-topic).

14. Writing pointless posts or comments (flood).

15. Publication of other people's materials (photos, images, fan art, texts, etc.) without links to the source, as well as if the author or the individual concerned is against publications on MAXMODAL. The individual concerned in this case can be a person who has something to do with the material, for example, he can be present in a photograph. The administration reserves the right to independently decide who is considered the individual concerned.

16. Creation of messages in a language other than languages of communication on MAXMODAL (English and Russian) or using transliteration.

17. Open publication of private information about other Users, containing correspondence with the Administration, if proper permission for such publication has not been obtained. The administration reserves the right to request such permission and determine whether it is obtained in the proper way in the context of applicable law.

18. Public discussion of the Administration's activity related to moderation.

19. In general, unconstructive, unreasoned criticism of the Administration, its partners, and other Users.

20. Publication of unofficial materials and news that may misinform Users.

21. Publication of posts and comments that violate the current legislation of the Russian Federation or international UN norms.

22. Quoting posts and comments containing violations of these Terms. Such quotation is equivalent to a corresponding violation of these Terms.

23. Publication of materials that violate the current legislation of the Russian Federation or international norms, including the norms governing copyright and / or related rights.

**The interaction of MAXMODAL Users is based on mutual respect and interest in the MAXMODAL theme. Users are solely responsible for any actions on MAXMODAL that contradict the current legislation of their country of residence or citizenship.**
